Statement of Privacy

This statement of privacy complies with the General Data Protection Regulation (GDPR) which regulates how an organization treats and/or uses the personal data of EU citizens, including organisations located outside of the EU. The GDPR replaces the national data protection laws which were in place prior to May 2018 with a single set of rules, directly enforceable in each EU member state. The GDPR's focus is the protection, collection and management of personal data, (i.e. data about individuals) and it applies to all businesses who hold or otherwise process personal data (including sole traders) of people in EU Member States.

GDPR gives people more rights over how companies collect and use personal data. The act specifically gives people the right to access, correct, delete, and restrict processing of personal data, and lays out strict guidelines about consent for data usage.

Dyspraxia/DCD Ireland is committed to protecting your privacy. This Statement of Privacy applies to The Dyspraxia/DCD website (www.dyspraxia.ie) and governs data collection and usage. By using the Dyspraxia/DCD website, you consent to the data practices described in this statement.

Collection of your Personal Information

Dyspraxia/DCD collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number for the purposes of registering your details as a member of Dyspraxia/DCD or a contact person from a member organisation of Dyspraxia/DCD, or as a participant/registrant for an event organised by Dyspraxia/DCD. Except to the extent required in some circumstances e.g. special dietary requirements, Dyspraxia/DCD does not request any other personal information.

There is also information about your computer hardware and software that is automatically collected by Dyspraxia/DCD. Use of your Personal Information

Dyspraxia/DCD collects and uses your personal information to operate the Dyspraxia/DCD web site (www.dyspraxia.ie) and deliver the services you have requested. Dyspraxia/DCD also uses your personally identifiable information to inform you of other products or services available from Dyspraxia/DCD through its main website (www.dyspraxia.ie) or affiliate websites.

Dyspraxia/DCDmay also contact you via surveys to conduct research, to seek your opinion of current services we provide, or of potential new services that may be offered.

Dyspraxia/DCD does not sell, rent or lease its customer lists to third parties. Dyspraxia/DCD may, from time to time, contact you on behalf of external partners about a particular offering that may be of interest to you such as training or participation in services offered by partner organisations. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Dyspraxia/DCD may share data with trusted partners to help us perform statistical analysis, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except in their provision of these services to Dyspraxia/DCD, and they are required to maintain the confidentiality of your information.

Dyspraxia/DCD web site will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Dyspraxia/DCD or the site; (b) protect and defend the rights or property of Dyspraxia/DCD; and, (c) act under exigent circumstances to protect the personal safety of users of Dyspraxia/DCD, or the public.

Use of Cookies

The Dyspraxia/DCD web site uses "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server.
